Top Concern of Educators


- Safety has become a primary driver for parents using school choice.
- School safety has a central place in the minds of students and parents today. One report says school shootings are “this generation’s 9/11.” The study found that 68 percent of individuals aged 14-29 say that school shootings are the nation’s most important issue.

Federal Government Impact Study

- On March 12, 2018, President Trump called for immediate action on a range of policies designed to protect schools and students.¹ The Trump Administration worked to build a bipartisan coalition to garner passage and enactment of two bills: HR 4909, Students, Teachers, and Officers Preventing (STOP) School Violence Act of 2018² and S. 2135, Fix NICS (National Instant Criminal Background Check System) Act.³
- Acknowledging there can be no one-size-fits-all solution to this complex problem, the US Government issued a report, which serves as a resource guide for families, educators, law enforcement officers, health professionals, and elected leaders to use as they consider the best ways to prevent, mitigate, and recover from acts of violence.

- Currently, SEE has programs underway in Georgia, Florida and several others slated for start across the Southeast.


Safety & Security Steps

- Typical timeline and plan is approximately 8-10 weeks for assessment and then recommendation







